Mr. Stephenson informed the Company that the coming year will be an extremely busy one for him as Chairman and CEO of AT&T Inc., as AT&T works to litigate, close and integrate its acquisition of Time Warner Inc. Because of this and the time required to effectively serve on the Emerson Board, Mr. Stephenson felt it was best to make room for someone with sufficient time to devote to the position. Mr. Stephenson's resignation is not due to any disagreement with the Company on any matter relating to its operations, policies or practices.

Emerson's management team and the Board of Directors would like to extend their thanks to Mr. Stephenson for his 11 years of loyal service to the Board, including his most recent role as Lead Independent Director. His counsel, leadership, innovative thinking and commitment to creating long-term value for shareholders, customers and employees has been key in helping reposition the Company to increase our relevance in the industries we serve and grow sales, earnings, and cash flow well into the future.
