## Explanation of Responses:

- \*\* Intentional misstatements or omissions of facts constitute Federal Criminal Violations. *See* 18 U.S.C. 1001 and 15 U.S.C. 78ff(a).
- (1) Due to miscommunication, the shares of restricted common stock and the stock appreciation rights granted the reporting person were incorrectly reported. The purpose of this Amended Form 4 is to correctly report the reduced amounts of those grants.
- (2) On March 29, 2011, the reporting person was granted 11,700 shares of restricted common stock. The shares will vest 25% per year on the first four anniversary dates from the date of grant.
- (3) On March 29, 2011, the reporting person was granted Stock Appreciation Rights (SARs) with respect to a total of 22,250 shares of common stock. The grant price for the SARs is \$18.84 per share of common stock, which was the closing price of the Issuer's common stock on that date. The SARs will vest 25% per year on the first four anniversary dates from the date of grant. They will expire on the earlier of (i) sixty days after termination of employment (one year if termination is due to death, disability or retirement), or (ii) seven years from the date of grant.
