(d) On July 28, 2009, the Board of Directors of Southwestern Energy Company (the "Company") elected Steven L. Mueller, the Company's President and Chief Executive Officer, as a director of the Board of Directors. Mr. Mueller was elected for a term expiring at the annual meeting of stockholders in 2010, at which time his continued service will be subject to stockholder approval. With the election of Mr. Mueller, the Board of Directors has seven (7) members.

The selection of Mr. Mueller was not pursuant to any arrangement or understanding between him and any other person. Mr. Mueller will not serve on any of the committees of the Board of Directors.

There are no transactions between Mr. Mueller and the Company that are required to be reported under Item 404(a) of Regulation S-K other than compensation arrangements relating to his position as the Company's President and Chief Executive Officer, all of which have been previously disclosed as required pursuant to Item 402 of Regulation S-K.
