These are deferred common stock units acquired pursuant to the Company's 2004 Stock Incentive Plan, the Deferred Compensation Plan for Non-Employee Directors and the dividend reinvestment feature of that plan. The deferred common stock units are converted into (1) shares of Company common stock on a one-for-one basis upon distribution. Distribution of shares of common stock occurs six months after a director's service on the Board terminates or upon another date or dates designated by the director pursuant to the Company's Deferred Compensation Plan for Non-Employee Directors.

Includes the deferred common stock units granted under one or more of the Company's directors' compensation plans. Also includes (2) 103.72 deferred common stock units acquired on 3/31/2008 pursuant to the dividend reinvestment features of those plans which will be distributed as described in footnote 1 above.
