(1) ESL Investors, L.L.C. ("Investors") distributed to its managing member, RBS Partners, L.P. ("RBS"), 3,110,297 shares of common stock, par value \$0.01 per share, of the Issuer ("Common Stock") in accordance with the terms of the limited liability company operating agreement of Investors. These shares of Common Stock represent a portion of the pro rata pecuniary interest of RBS in the shares of Common Stock it manages for Investors. These shares of Common Stock were held in an account established by the investment member of Investors.

(2) Following the reported transaction, 3,110,297 shares of Common Stock are held directly by RBS, and 13,901,997 shares of Common Stock continue to be held in an account established by the investment member of Investors. In addition, the ownership of Common Stock by the following entities remains unchanged: ESL Partners, L.P. ("Partners") holds 48,271,682 shares; ESL Institutional Partners, L.P. ("Institutional") holds 338,239 shares; CRK Partners, LLC ("CRK LLC") holds 747 shares; and ESL Investment Management, L.P. ("Investment Management") holds 15,999 shares. Accordingly, the reported transaction has not changed the aggregate number of 65,638,961 shares of Common Stock that may be deemed to be beneficially owned by ESL Investments, Inc., Edward S. Lampert, CRK LLC, Investors, Partners, Institutional, Investment Management, RBS and RBS Investment Management, LLC.
