Remarks:

On March 13, 2006, Mr. Ward entered into a forward sale agreement (the "Agreement") relating to up to 7,815,808 shares (the "Shares") of the common stock of Chesapeake Energy Corporation (the "Company").

(a) If the average closing price of the common stock for the ten business days following March 12, 2009 (the "Settlement Price") is less than the Hedged Value (the "Hedged Value"), the Settlement Ratio will be equal to the sum of the Hedged Value and the Settlement Price.

(b) If the Settlement Price is greater than the Hedged Value but less than \$46.9017 (the "Upside Limit"), the Settlement Ratio will be equal to the sum of the Hedged Value and the Settlement Price.

(c) If the Settlement Price is equal to or greater than the Upside Limit, the Settlement Ratio will be equal to the sum of the Hedged Value and the Settlement Price.

In consideration therefor, the Agreement provides that Mr. Ward will receive a purchase price of \$172,077,210.
