**Item 2.01. Completion of Acquisition or Disposition of Assets.**

On October 27, 2008, The Manitowoc Company, Inc. ( Manitowoc ), completed the previously announced acquisition (the Acquisition ) of all of the issued and to be issued ordinary share capital of Enodis plc ( Enodis ) from the existing shareholders of Enodis for cash of 328 pence per

share. Enodis is a global leader in the design and manufacture of innovative equipment for the commercial foodservice industry. The Acquisition was valued at approximately \$2.7 billion, including the assumption of Enodis net debt, and was funded by loan facilities made available to Manitowoc under its Credit Agreement, dated as of April 14, 2008, with JPMorgan Chase Bank, N.A., as Administrative Agent, Deutsche Bank AG New York Branch and Morgan Stanley Senior Funding, Inc., as Syndication Agents, and BNP Paribas, as Documentation Agent, as amended.

On October 27, 2008, Manitowoc issued press releases announcing, respectively, the completion of the Acquisition and the effectiveness of the Scheme of Arrangement under which the Acquisition was implemented. The press releases are filed herewith as Exhibits 99.1 and 99.2, respectively, and incorporated herein by reference.
