Item 1.01 Entry into a Material Definitive Agreement.

On June 27, 2010, The Valspar Corporation announced that it had entered into an agreement with Watty Limited, an Australian corporation (Watty), to acquire all outstanding capital shares of Watty. Watty distributes leading paint brands to retail customers through home improvement centers and hardware outlets and to trade customers through a network of 140 company-owned stores. Pursuant to the agreement, Valspar has agreed to acquire all outstanding Watty shares for a purchase price of approximately A\$142 million. Valspar will also assume Watty's existing debt. The transaction is subject to customary conditions, including approval by Watty shareholders and regulatory authorities.

The description of the agreement with Watty set forth herein does not purport to be complete and is qualified in its entirety by reference to the full text of the agreement, entitled Scheme Implementation Deed, attached hereto as Exhibit 99.1, which is incorporated herein by reference.
