Registration of Additional Shares

The Registrant filed a Registration Statement with the Commission on September 22, 2000 on Form S-8, incorporated herein by reference, relating to the Registrant's 1996 Incentive and Nonqualified Stock Option Plan, as amended (the "1996 Plan") and the Non-Employee Directors Stock Plan (as amended and restated, the "Directors Plan"), registering 425,000 shares of Common Stock reserved for issuance upon exercise of options granted or to be granted under the 1996 Plan and the Directors Plan. The Registrant filed a subsequent Registration Statement with the Commission on May 24, 2002 on Form S-8, incorporated herein by reference, relating to the Registrant's 2002 Incentive and Nonqualified Stock Option Plan, as amended and renamed the 2002 Equity Incentive Plan (the "2002 Plan"), and the Directors Plan, registering 200,000 shares of Common Stock reserved for issuance upon exercise of options granted or to be granted under the 2002 Plan and an additional 25,000 shares of common stock reserved for issuance upon exercise of options granted or to be granted under the Directors Plan, increasing the number of shares of Common Stock authorized for issuance under the Directors Plan from 40,000 to 65,000. On July 20, 2006, the Registrant filed a subsequent Registration Statement with the Commission registering an additional 25,000 shares of Common Stock authorized for issuance under the Directors Plan increasing the total shares authorized for issuance under the Directors Plan from 65,000 to 90,000. On May 20, 2009, the shareholders of the Registrant approved an amendment to the Directors Plan, increasing the number of shares of Common Stock authorized for issuance under the Directors Plan from 90,000 to 115,000. This Registration Statement shall serve to register the additional 25,000 shares approved for issuance under the Directors Plan.
