On January 3, 2007, PPL Corporation (“PPL”) and PPL Electric Utilities Corporation (“PPL Electric”) issued a press release announcing the retirement for health reasons of John F. Sipics, who had been serving as PPL Electric’s President and as a member of its Board of Directors. The effective date of Mr. Sipics’ resignation in both capacities was January 1, 2007. William H. Spence, PPL’s Executive Vice President and Chief Operating Officer and a member of PPL Electric’s Board of Directors, has been elected as PPL Electric’s President, effective January 2, 2007, and will serve in such capacity pending decisions regarding Mr. Sipics’ permanent successor.
