The Schedule 13G previously filed by the undersigned with respect to the Class A Common Stock, par value \$0.001 per share (the "Class A Common Stock"), of Viacom Inc. is hereby amended as follows:

Item 2.

Item 2(a) is hereby amended and restated in its entirety as follows:

Name of Person Filing: This Statement is being jointly filed by National Amusements, Inc. ("NAI"), NAI Entertainment Holdings LLC ("NAI EH") and Sumner M. Redstone. NAI EH is a wholly owned direct subsidiary of NAI. Mr. Redstone is the Chairman and Chief Executive Officer of NAI EH and NAI.

Item 2(b) is hereby amended and restated in its entirety as follows:

Address of Principal Business Office: The principal business address of Sumner M. Redstone, NAI and NAI EH is 846 University Avenue, Norwood, MA 02062.

Item 2(c) is hereby amended and restated in its entirety as follows:

Citizenship: The State of incorporation of NAI is Maryland; the state of organization of NAI EH is Delaware; and Mr. Redstone is a citizen of the United States.

Item 4.

Item 4 is hereby amended and restated in its entirety as follows:

(a) Amount Beneficially Owned: NAI EH beneficially owns 14,329,561 shares of Class A Common Stock; NAI beneficially owns 40,865,882 shares of Class A Common Stock (including the shares owned by NAI EH); Sumner M. Redstone beneficially owns 40,865,922 shares of Class A Common Stock (including the shares owned by NAI and NAI EH).

(b) Percent of Class: 27.9% with respect to NAI EH; 79.5% with respect to NAI and Sumner M. Redstone.

(c) Number of shares as to which the person has:

(i) sole power to vote or to direct the vote: 14,329,561 shares of Class A Common Stock with respect to NAI EH; 40,865,882 shares of Class A Common Stock with respect to NAI (including the shares owned by NAI EH); 40,865,922 shares of Class A Common Stock with respect to Sumner M. Redstone (including the shares owned by NAI and NAI EH);

(ii) shared power to vote or to direct the vote: None;

(iii) sole power to dispose or to direct the disposition: 14,329,561 shares of Class A Common Stock with respect to NAI EH; 40,865,882 shares of Class A Common Stock with respect to NAI (including the shares owned by NAI EH); 40,865,922 shares of Class A Common Stock with respect to Sumner M. Redstone (including the shares owned by NAI and NAI EH);

(iv) shared power to dispose or direct the disposition: None.
