Capital Group International, Inc. CGII does not have investment power or voting power over any of the securities reported herein. However, by virtue of Rule 13d-3 under the Act, CGII may be deemed to "beneficially own" 134,261,980 shares or 7.8% of the 1,718,666,329 shares of American Depositary Shares, each representing one Ordinary Share believed to be outstanding.

Capital Guardian Trust Company, a bank as defined in Section 3(a) (6) of the Act is deemed to be the beneficial owner of 88,050,740 shares or 5.1% of the 1,718,666,329 shares of American Depositary Shares, each representing one Ordinary Share believed to be outstanding as a result of its serving as the investment manager of various institutional accounts.
