The remaining 9,088 shares of Common Stock underlying this restricted stock unit award vest in ratable installments on January 1 of each of the first, second, (1) third, fourth and fifth calendar years following the grant date. The restricted stock unit award is subject to payment within 75 days following the applicable vesting date. Each unit represents a right to receive one share of Common Stock or an amount equal to the market value of the Common Stock underlying the award on the applicable vesting date.
