Aetna's presence in retail stores will allow us to develop trusted relationships with consumers in their local communities, helping us retain and grow membership.

Aetna has a proud 164-year history. We have established our company as a proven leader in the health care marketplace. This combination will enable us to remain in this leadership position and provide greater value to the people we serve.

The work you do every day will be needed to fulfill the combined company's vision. CVS Health is committed to keeping a strong Aetna management team in place to lead Aetna as a separate business unit of CVS Health. CVS Health has also committed to maintain the Aetna brand in the marketplace in recognition of the exceptional value we provide. Together we will build on our distinguished history and position our business for growth for many years to come.

This announcement is just the first step in a lengthy process to bring the two companies together. We expect the transaction to close in the second half of 2018 after all regulatory and shareholder approvals. Until then, we will continue to operate in all respects as two independent companies. Even after the transaction closes, it will take time for the companies to completely integrate and for change to occur. I ask that you stay focused on doing the jobs you do so well and remain dedicated to the people we serve.
