ESL Investment Management, LLC, a Delaware limited liability company ("ESLIM"), is the investment manager of Limited and the general partner of KPI. RBS Investment Management, LLC, a Delaware limited liability company ("RBSIM"), is the general partner of Institutional. RBS Partners, L.P. is the manager of Investors. In the aforementioned capacities, ESL, Limited, Institutional, Investors and KPI each may be deemed to be the beneficial owner of the shares of Sears, Roebuck and Co. common stock beneficially owned by the other members of the group.

As of June 30, 2003, (i) ESL was the record owner of 18,534,370 shares of common stock of Sears, Roebuck and Co.; (ii) Limited was the record owner of 2,319,114 shares of common stock of Sears, Roebuck and Co.; (iii) Institutional was the record owner of 697,119 shares of common stock of Sears, Roebuck and Co.; (iv) Investors was the record owner of 8,073,364 shares of common stock of Sears, Roebuck and Co.; and (v) KPI was the record owner of 1,476,033 shares of common stock of Sears, Roebuck and Co.
