SHARE RESTRUCTURING APPROVED

TORONTO, ONT. Peace Arch Entertainment Group Inc. (AMEX: PAE; TSX: PAE.A , PAE.B) is pleased announce the results of its shareholders meetings held on February 11, 2004.

The shareholders approved the Company's plan to restructure its share capital, by which all Class A Multiple Voting Shares and all Class B Subordinate Voting Shares will be merged into one class of common shares all having one vote each.

The effective date of implementation of the restructuring is subject to necessary legal and securities filings being done, and that effective date will be announced when known.

At the same time, the shareholders approved removal of all restrictions on the issue and transfer of the Company's shares.

The meeting elected two new Directors, Ms. Mara Di Pasquale, C.A. and Mr. D. Jeffrey Andrick. They join Charles Falzon, Ian Fodie, Gary Howsam, Juliet Jones, Nelson Thall, and Richard Watson, who were re-elected.

Pricewaterhouse Coopers LLP, Chartered Accountants, were again appointed as auditors of the Company.

The shareholders also authorized the board of directors to change the jurisdiction of the Company from British Columbia to Ontario. The Company has not announced any plans to act on this proposal.
