The PSUs vest in three equal installments on each of March 1, 2011, March 1, 2012 and March 1, 2013.
- (3) Each RSU represents a contingent right to receive one share of the Issuer's Class A Common Stock upon vesting.
- (4) The RSUs vest in three equal installments on each of March 1, 2011, March 1, 2012 and March 1, 2013.
