- (3) NEA Partners 10 received 9,650 shares of Common Stock of the Issuer in the distribution by NEA 10 on August 21, 2013.

The Reporting Person disclaims beneficial ownership within the meaning of Section 16 of the Securities Exchange Act of 1934, as amended, or otherwise of such portion of the shares of Common Stock of the Issuer held by NEA Partners 10 in which the Reporting Person has no pecuniary interest.

- (4) NEA Partners 10 made a pro rata distribution for no consideration of an aggregate of 9,650 shares of Common Stock of the Issuer to its limited partners on August 21, 2013.

- (6) New Enterprise Associates, LLC ("NEA LLC") received 1,414 shares of Common Stock of the Issuer in the distribution by NEA Partners 10 on August 21, 2013.

The shares are held directly by the Sandell Family Trust. The Reporting Person disclaims beneficial ownership within the meaning of Section 16 of the Securities Exchange Act of 1934, as amended, or otherwise of such portion of the shares of Common Stock of the Issuer held by the Sandell Family Trust in which the Reporting Person has no pecuniary interest.
