- (1) Effective upon the consummation of the Issuer's initial public offering of its common stock, par value \$0.01 per share (the "Common Stock"), the Issuer effectuated a distribution, exchange, and stock split. ("LGP"), which is the management company of GEI V and GEI Side V, the manager of TCS, and an affiliate of GEIC and Holdings. LGP Management, Inc. is the general partner of
