We continue to make progress in the integration planning for the combination of Covidien and Medtronic. As we've shared previously, we expect the transaction to close by the end of this calendar year or early next year. Together, the combined companies will further advance our position in our industry.

Recently we announced the new Executive Committee that will be in place when the new company is formed. Upon close, the new company will be comprised of four major business groups and four global regions led by a new Executive Committee. This leadership team has been named to ensure alignment in our leadership as we make progress in our integration plans for the close of the acquisition.

Omar Ishrak will remain as chairman and chief executive officer of the new company, Medtronic plc. Three of the business groups of the new company will be led by Medtronic's current group leaders: Mike Coyle, executive vice president and president of the Cardiac and Vascular Group (CVG), Hooman Hakami, executive vice president and president of the Diabetes Group, and Chris O'Connell, executive vice president and president of the Restorative Therapies Group (RTG). Bryan Hanson, currently Covidien Group president, will become executive vice president and president of the fourth major business group, a newly formed Covidien Group.

The Executive Committee members will assume their roles as part of the new company upon the close of the acquisition. Until that time, they will continue in their current roles and there should be no change in your dealings with either company. In the meantime, both companies must and will continue to operate as independent entities. When this transaction is completed, we will be presenting the new value propositions we believe we can bring to support your business.

We are excited about the opportunities the combination of Medtronic and Covidien will bring, including a compelling and complementary offering of products and services with an industry leading team of professionals.

We remain extremely grateful for your business and your partnership, and we look forward to our continued work together on behalf of patients around the world.
