**Scientific Advisory Board (SAB) Communication from Dr. Mark Turco**

Dear Scientific Advisory Board:

On behalf of Covidien Vascular Therapies, I wanted to update you on information we are sharing with key physicians and clinical investigators involved in our Stellarex drug-coated angioplasty balloon (Stellarex DCB) clinical and R&D program.

In connection with its review of the pending acquisition of Covidien by Medtronic, the Federal Trade Commission (FTC) has investigated the parties' drug coated balloon (DCB) programs. As a result, Covidien and Medtronic have agreed to divest the Stellarex DCB program and Covidien has entered into an agreement with medical device company Spectranetics under which Spectranetics will acquire the Stellarex DCB program and product line.

This divestiture applies only to Covidien's drug coated balloon technology and does not include any other technologies. The transaction with Spectranetics is expected to close promptly after consummation of Medtronic's acquisition of Covidien and receipt of required regulatory approvals.

Spectranetics is committed to continuing the ILLUMENATE trial series, an ongoing clinical investigation of the safety and effectiveness of the Stellarex DCB, as well as identifying future indications for this platform. Covidien will work closely with Spectranetics and investigators to ensure that these trials are transitioned appropriately.

This decision is no reflection on the outstanding work that has taken place. Covidien is proud of the quality of the research and development of the ILLUMENATE trial series and the Stellarex DCB program. Over our series of SAB meetings, we have discussed drug-device therapies and the strategic importance of our program in particular. The guidance and strategic input has been critical to the progress to date and in setting the stage for future opportunities to improve patient care.
