Notwithstanding the foregoing, if the 2028 Notes are redeemed on or after February 15, 2028 (the date that is three months prior to their maturity date) or the 2048 Notes are redeemed on or after November 15,

2047 (the date that is six months prior to their maturity date), the 2028 Notes and the 2048 Notes, respectively, will be redeemed at a redemption price equal to 100% of the principal amount of the notes to be redeemed, plus accrued and unpaid interest to, but excluding, the date of redemption. February 15, 2028 and November 15, 2047 are the Par Call Dates in respect of the 2028 Notes and the 2048 Notes, respectively.
