(1) Immediately following the exercise of 600 options, Ms. Dwyer directly owned 43,103 shares of the issuer's common stock.

Stock option had a 10-year term, vested as to 10% of the grant amount on the first nine anniversary dates of July 28 and vested as to the remaining 10% 9.75 years after the option grant date of July 28, 1997. July 28, 1998 reflects the one-year anniversary date from the date of the stock option grant.
