The grant vests in four equal quarterly increments as of (1) October 21, 2005, January 21, 2006, April 21, 2006 and July 21, 2006. DSUs are converted into common stock three years after the effective date, unless further deferred by the recipient, or upon termination, whichever date occurs sooner. Reporting date of January 17, 2006 is the date the terms of the grants were irrevocably fixed and communicated to grantee.
