- (1) Represents 116,900 restricted stock units granted to the reporting person under the issuer's 2015 Equity Incentive Plan. The restricted stock units vest as follows: (i) 23,100 of the restricted stock units vest in three equal annual installments on March 17, 2018, March 17, 2019 and March 17, 2020, provided that the reporting person remains employed by the issuer as of each vesting date, and (ii) up to 93,800 of the restricted stock units vest in three equal annual installments beginning on the date in 2018 that the issuer's compensation committee certifies that certain performance metrics are achieved, provided that the reporting person remains employed by the issuer as of each vesting date.
