Item 1.
Security and Issuer.
This Schedule 13D relates to Common Stock, par value $\$ 0.001$ per share (the "Common Stock"), issued by Data Storage Corporation (the "Issuer"). The Issuer's principal executive office is located at 401 Franklin Avenue, Garden City, New York 11530.

Item 2.
Identity and Background.
Clifford Stein (the "Reporting Person") is an individual whose address is 401 Franklin Avenue, Suite 103, Garden City, New York 11530. The Reporting Person is the President of Savitar Realty Advisors, 5345 Pine Tree Drive, Miami Beach, Florida, 33140 and is a member of the Board of Directors of the Issuer. During the last five years, the Reporting Person has not been convicted in a criminal proceeding (excluding traffic violations or similar misdemeanors). During the last five years, the Reporting Person has not been a party to a civil proceeding of a judicial or administrative body of competent jurisdiction and as a result of such proceeding was or is subject to a judgment, decree or final order enjoining future violations of, or prohibiting or mandating activities subject to, federal or state securities laws or finding any violation with respect to such laws. The Reporting Person is a United States citizen.

Item 3. Source and Amount of Funds or Other Consideration.
On September 7, 2012, the Reporting Person agreed to purchase 833,333 shares of Common Stock (the "Shares") from the Issuer for an aggregate consideration of $\$ 125,000$ in cash. The purchase was consummated on September 10, 2012. After such purchase, the Reporting Person beneficially owned 3,349,490 shares of Common Stock. The Reporting Person also holds options to purchase 9,920 shares of Common Stock, 3,855 of which are currently exercisable and the remainder of which vest ratably through 2014. The acquisition was financed with personal funds.

Item 4.
Purpose of Transaction.
The shares were acquired for investment purposes. The Reporting Person does not at the present time have any plans or proposals which relate to or would result in:
(a) The acquisition by any person of additional securities of the Issuer, or the disposition of securities of the Issuer, except the acquisition of shares underlying warrants directly or indirectly owned by him as of the date hereof;
(b) An extraordinary corporate transaction, such as a merger, reorganization or liquidation, involving the Issuer or any of its subsidiaries;
(c) A sale or transfer of a material amount of assets of the Issuer or any of its subsidiaries;
(d) Any change in the present Board of Directors or management of the Issuer, including any plans or proposals to change the number or term of directors or to fill any existing vacancies on the Board;
(e) Any material change in the present capitalization or dividend policy of the Issuer;
(f) Any other material change in the Issuer's business or corporate structure;
(g) Changes in the Issuer's Certificate of Incorporation, by-laws or instruments corresponding thereto or other actions which may impede the acquisition of control of the Issuer by any person;
(h)

Causing a class of securities of the Issuer to be delisted from a national securities exchange or to cease to be authorized to be quoted in an inter-dealer quotation system of a registered national securities association;
(i) A class of equity securities of the Issuer becoming eligible for termination of registration pursuant to Section $12(\mathrm{~g})(4)$ of the Securities Exchange Act of 1934; or
(j) Any action similar to any of those enumerated above.

Item 5.
Interest in Securities of the Issuer.
As of the date hereof and as more fully described in Item 3 above, the Reporting Person may be deemed to be the direct and indirect beneficial owner of an aggregate of 3,349,490 shares of Common Stock and options to purchase 9,920 shares of Common Stock, 3,855 of which are currently exercisable and the remainder of which vest ratably through 2014. The Reporting person has sole voting and dispositive power over all such securities.

The 3,349,490 shares of Common Stock and the 3,855 exercisable stock options beneficially owned by the Reporting Person represent $10.9 \%$ of the $30,723,288$ issued and outstanding shares of Common Stock as of September 10, 2012 based on $29,056,622$ shares of Common Stock outstanding as of June 30, 2012 as reported by the Issuer in its Quarterly Report on Form 10-Q for the quarter ended June 30, 2012 plus 166,666 shares issued on September 10, 2012 as reported by the Issuer in its Current Report on Form 8-K filed with the Securities and Exchange Commission on September 13, 2012.
