NOTICE TO THE MARKET

São Paulo, December 04, 2018 - Braskem (B3: BRKM5, BRKM3, BRKM6; NYSE: BAK; LATIBEX: XBRK), the largest producer of thermoplastic resins in the Americas and the global leader in the production of biopolymers, was included in the Corporate Sustainability Index (ISE) of the B3 for the fourteenth time.

Braskem's continuity in the index reflects the Company's ongoing commitment to good corporate governance practices, social responsibility, financial management and environmental preservation.

The new ISE portfolio comprises 35 shares of 30 companies representing 13 industries, with a joint market cap of R\$1.73 trillion, equivalent to 49% of the total market cap of all companies traded on the Brazilian exchange. The index composition will be in effect from January 07, 2019, to January 03, 2020.
