Pyramis Global Advisors, LLC ("PGALLC"), 900 Salem Street, Smithfield, Rhode Island, 02917, an indirect wholly-owned subsidiary of FMR LLC and an investment adviser registered under Section 203 of the Investment Advisers Act of 1940, is the beneficial owner of 11,988,750 shares or 4.404% of the outstanding Common Stock of GRAN TIERRA ENERGY INC as a result of its serving as investment adviser to institutional accounts, non-U.S. mutual funds, or investment companies registered under Section 8 of the Investment Company Act of 1940 owning such shares. The number of shares of Common Stock of GRAN TIERRA ENERGY INC owned by the institutional account(s) at December 31, 2013 included 11,260,660 shares of Common Stock resulting from the assumed conversion of 11,260,660 shares of GRAN TIERRA ENERGY INC (1 shares of Common Stock for each share of Convertible Preferred Stock).

Edward C. Johnson 3d and FMR LLC, through its control of PGALLC, each has sole dispositive power over

11,988,750 shares and sole power to vote or to direct the voting of 11,876,210 shares of Common Stock owned by the institutional accounts or funds advised by PGALLC as reported above.

Pyramis Global Advisors Trust Company ("PGATC"), 900 Salem Street, Smithfield, Rhode Island, 02917, an indirect wholly-owned subsidiary of FMR LLC and a bank as defined in Section 3(a)(6) of the Securities Exchange Act of 1934, is the beneficial owner of 1,350,560 shares or 0.496% of the outstanding Common Stock of the GRAN TIERRA ENERGY INC as a result of its serving as investment manager of institutional accounts owning such shares. The number of shares of Common Stock of GRAN TIERRA ENERGY INC owned by the institutional account(s) at December 31, 2013 included 1,350,560 shares of Common Stock resulting from the assumed conversion of 1,350,560 shares of GRAN TIERRA ENERGY INC (1 shares of Common Stock for each share of Convertible Preferred Stock).

Edward C. Johnson 3d and FMR LLC, through its control of Pyramis Global Advisors Trust Company, each has sole dispositive power over 1,350,560 shares and sole power to vote or to direct the voting of 1,012,610 shares of Common Stock owned by the institutional accounts managed by PGATC as reported above.

Members of the family of Edward C. Johnson 3d, Chairman of FMR LLC, are the predominant owners, directly or through trusts, of Series B voting common shares of FMR LLC, representing 49% of the voting power of FMR LLC. The Johnson family group and all other Series B shareholders have entered into a shareholders' voting agreement under which all Series B voting common shares will be voted in accordance with the majority vote of Series B voting common shares. Accordingly, through their ownership of voting common shares and the execution of the shareholders' voting agreement, members of the Johnson family may be deemed, under the Investment Company Act of 1940, to form a controlling group with respect to FMR LLC.
