#### Financing Support Agreement

Origin Agritech Ltd. (the "Company") has entered into a Financing Support Agreement (the "Agreement") dated as of January 4, 2019, by and among Tiger Capital Fund SPC ("Tiger Fund"), Long Han Investment Management Co., Ltd. ("Longhan") and the Company. This agreement allows Tiger Fund to join Longhan to invest in the Company under the Share Subscription Agreement (the "Share Subscription Agreement") dated as of October 16, 2018 by and between Longhan and the Company, and the Company agrees to cooperate in connection with the arrangement of such financing as may be reasonably requested by Longhan. In connection with the Agreement, the parties also agreed to the amendment of certain terms of the Share Subscription Agreement and the assignment of the right to purchase shares under the Share Subscription Agreement from Longhan to Tiger Fund. In addition, pursuant to the terms of the Agreement, the Company has issued to Tiger Fund a warrant for 1,000,000 shares of common stock of the Company, exercisable upon the closing of the transactions contemplated under the Share Subscription Agreement.
