Pursuant to Rule 13d-3(d)(1) of the Act, the above number and other references herein to the number of shares of Class A Common Stock Mr. Paxson beneficially owns generally includes 8,311,639 shares of Class B Common Stock of the Company beneficially

owned by Mr. Paxson, which may be converted to an equal number of shares of Class A Common Stock at any time, and fully vested options to purchase 666,666 shares of Class A Common Stock.

The Company's Annual Report on Form 10K for the Year Ended December 31, 2001, filed March 14, 2002, reports that as of March 1, 2002, there were 56,423,527 shares of Class A Common Stock and 8,311,639 shares of Class B Common Stock issued and outstanding. Accordingly, Mr. Paxson beneficially owns approximately 43.13% of the Company's outstanding Class A Common Stock (which includes 8,311,639 shares of Class B Common Stock and vested options to purchase 666,666 shares of Class A Common Stock).

ITEM 5. (b) Mr. Paxson has sole power to vote or direct the vote of, and sole power to dispose or direct the disposition of 28,208,567 shares of Class A Common Stock. No shares are held with shared voting or dispositive power.

ITEM 5. (c) As of April 14, 2002, Mr. Paxson transferred 13,000 shares of Class A Common Stock held in the name of Paxson Enterprises, Inc., a corporation controlled by Mr. Paxson, in a private transaction in consideration for services rendered.

On April 15, 2002, Mr. Paxson effected the sale of 565,000 shares of Class A Common Stock held in the name of Second Crystal Diamond Limited Partnership, which is controlled by Mr. Paxson, at an average price of \$10.83 per share. All of the sales were effected pursuant to Rule 144 and were accomplished through OTA Limited Partnership as broker.
